Entries: Use the 2023 RMDS entry form and be sure to sign all spaces on the back. \$35 per class, \$30 non-refundable office fee. No USEF fee or non-member fees. Need not be member of RMDS but highly encouraged. A copy of your 2023 RMDS Horse/Rider/Owner cards must be included for scores to count for RMDS. \$20 late/change fee after closing date. \$50 Fee for all returned checks. **Make checks payable to Pikes Peak Dressage and send entries with check to Secretary.** Show arenas will be 20X60 – Intro, Eventing, applicable Western Dressage tests and Training 1-2 may be held in 20X40. Times are tentative and will be available 3-4 days prior to show at www.horseshowoffice.com. Helmets are required for western dressage. Remember – RMDS competitions follow USEF Dressage Competition Level 1 rules. Any questions, please contact the Technical Delegate or the Show Secretary.

Stabling: \$50 per overnight stall, \$35 for a day stall – 10x12 semi permanent wood stalls with hard floors. You must bring your own shavings and shavings are required.

Concessions will be available on grounds – great restaurant on site! Vet and farrier on call. Volunteers very welcome – if you have some time, please contact the show manager.

Refunds: Up to closing date, all fees refunded except office fee. From day after closing to day prior to competition, class fees will be refunded only if ride(s) can be filled from wait list. During competition days **no refunds including Acts of God.** **Office fee is nonrefundable.**

Awards: Ribbons to 6th place all divisions. Ties broken if collective marks differ, otherwise left tied.

Directions to Latigo Trails: From North near I25 - Take exit 163 for County Line Rd toward Palmer Lake, Turn left onto S County Line Rd/Palmer Divide Rd, After 5.2 miles Turn right onto CO-83 S, after 4.2 miles Turn left onto Hodgen Rd, after 8.5 miles Turn right onto Meridian Rd, after 4 miles turn left onto Latigo Blvd, after 1.1 miles turn left onto Halleluia Trail. Facility on right. Google directions are great for other starting points.
