PONY DIVISION: Any animal not over 148 centimeters without shoes, or 149 centimeters with shoes are classified as ponies. A copy of the Federation Standard or Temporary Measurement Certificate must be submitted with the entry for each pony possessing a Measurement Certificate and competing in Dressage or Dressage Sport Horse Breeding classes limited to ponies. If a pony is not in possession of a fully and correctly completed Measurement Certificate, the Competition Management may order the pony to be measured by an eligible Dressage Technical Delegate and the Competition Veterinarian and/or a Judge, pursuant to GR505, GR506, and GR508.

ENTRIES/FEEES: USE SEPARATE ENTRY FORMS FOR EACH SHOW. Make checks payable to: **AHIEC**. \$35.00 per class USDF Intro-Fourth Level; \$45.00 per class for FEI & Freestyles; \$10.00 addl. divisions; \$10.00 USDF Qualifying fee; \$18.00 office fee per horse/rider combination, PER SHOW; \$12.00 USEF drug fee PER SHOW; \$20.00 fee for each change after closing. \$20 USEF non-member fee for each horse, rider, owner, trainer, lessee, and a \$5 breed/discipline fee. NEW \$20 USDF non-member fee with USDF non-member card or \$25 USDF non-member fee without USDF non-member card per horse, rider, owner. ENCLOSE copies of membership cards for rider, owner, trainer & horse with entry. ENCLOSE Negative Coggins test drawn in 2008. See page C-12. There will be a \$40 bad check fee plus any collection/bank fees. Send entry to secretary. Incomplete entries will be returned! You must use the 2008 RMDS Entry Form-use separate form for each show. Post entries accepted with management approval and with a \$25 fee. Entries accepted based on postmark. Enclose a legal sized Self-Addressed Stamped Envelope (SASE) with entry for confirmation letter.

REFUNDS: Up to closing date all fees refunded except Office fee. After closing date class fees will be refunded only if class can be filled. During competition days, no refunds of any kind for any reason. The office fee is never refundable. After closing date, stabling refunded only if stall is filled.

TIMES: Secretary will not call times. Tentative ride times will be mailed separately. Official ride times will be posted Friday afternoon in show office.

AWARDS: Ribbons to sixth place for each division. A variety of special awards will be awarded. (USDF Intro Tests & Freestyles not eligible for High-Point Awards.) The USDF/Dover Adult Amateur Medal will be awarded both Saturday and Sunday to the Adult Amateur riding Second Level Test 3 with the highest score of at least 58% or better who is a USDF group or participating member.

STABLING: Temporary stalls w/ full doors, 10x10. \$30/per night, no bedding provided. Shavings available for purchase on grounds OR pre-order & pay on your entry. Shavings \$8.00/bag.

DIRECTIONS: From Denver take I-25 to US 36 through Boulder, AHIEC is about 8 miles north of Boulder at intersection of US 36 and Nelson Road. From North take I-25 to CO 66 (Longmont)-go west to US 36 and then south 5.2 miles. AHIEC is on west side of road.

ARENAS: Indoor 20x60m-sand/wood and Outdoor 20x60m-sand. Warm-up-sand/squeegee.

OTHER: DOGS ON LEASHES!! May use small arena for Intro thru First Level test 1, except Training 4 due to qualifying rides. Lunging in designated areas only. Management reserves the right to make changes, cancel or combine classes, and refuse entries, if needed. Sharps containers will be available for disposal of needles and sharp instruments. Improper disposal may result in up to a \$100 fine. Every class offered herein which is covered by the rules and specifications of the current USEF Rule Book will be conducted and judged in accordance therewith.
