Grand Valley Dressage Society is going cyber in the year 2022! Beginning with our October show we will be using electronic scribing which will allow us to get results out to competitors much quicker, and minimize the number of volunteers needed to process scores.

To achieve this, we are offering a scribing clinic for both new and experienced scribes. The schedule for this clinic will be as follows:

**Friday, August 5th 6:30-8:30 PM. Ridgeline Community Center in Spyglass Ridge 2694 Lookout Ln. Grand Junction, CO.** Learn to scribe. Amber Benson will instruct those new to scribing on the basic principles and process for being a scribe. After the lecture on scribing basics, there will be practice on tablets using the LiveScore system and videotaped rides to help participants learn the basic process of scribing electronically.

**Saturday, August 6th 8:00 AM-11:00 AM. Roy Yates Horse Training 2033 J Rd. Fruita, CO. (Bring water, chair and hats)** Practice scribing electronically with live demonstration horses. A variety of tests will be ridden by local competitors to give new and experienced scribes an opportunity to work with the LiveScore System on a variety of different tests. If you are an experienced scribe this is an opportunity to get familiar with the electronic scribing process before a live show. If you are new to scribing this gives you experience scribing in a show-like environment using the electronic scoring system.
